## **Welcome**

---

Club Kaboom Volleyball, Inc. is a 501c3 non-profit organization established to provide affordable, quality volleyball training to athletes in the Houston area to help prepare them for collegiate careers and also to assist athletes in seeking out college scholarship opportunities. In support of that mission, we are proud to offer the Kaboom Fee Assistance Scholarship Program to provide financial assistance to those who qualify.

## **About the program**

---

The Kaboom Fee Assistance Scholarship Program is a program that takes into consideration the athlete's financial need, as well as her athletic achievements and aspirations, good citizenship and college potential, with the objective of remaining flexible to support the diverse needs of athletes. We hope to be able to give some athletes a chance to play club volleyball that might not otherwise have the opportunity to do so. Athletes who apply by the deadline and qualify are allocated a scholarship at one of three levels:

**White (\$1 to \$250)**

**Black (\$251 to \$500)**

**Gold (\$501 to 90% of season fee)**

## **How to Apply**

---

If you are interested in receiving a Fee Assistance Scholarship, please read this information packet thoroughly, and then, detach and return the completed application form, along with a copy of your 2008 tax return by **August 15, 2009** to Shafonia Sumrall at 2355 Emory Knoll Drive, Fresno, TX 77545.

## **Recipient Selections and Notifications**

---

Scholarships will be awarded on an as needed, first come, first serve basis, according to the criteria as explained in this application, using a sliding scale to determine financial need. Scholarship recipients will be notified on **September 1, 2009**.

## **Application of Fees**

---

If you are chosen as a recipient, the scholarship money you receive will be applied directly to your club fee account, and you will be responsible for the remaining amount. Shafonia will coordinate an acceptable payment schedule for the remaining fees.

## **Requirements for Scholarship Recipients**

---

- 1) Scholarship recipients are required to participate fully in ALL fundraising activities and may be required to work skills sessions or camps as needed throughout the season as well.
- 2) Starting this season, all recipients will also be required to volunteer hours working in the new concession stand in the Kaboom building:  
Gold level recipients – minimum of 20 hours during season  
Black level recipients – minimum of 15 hours during season  
White level recipients – minimum of 10 hours during season

Once all scholarship recipients are identified, Shafonia will coordinate with everyone and work out a volunteer schedule.

- 3) Scholarship recipients must strictly adhere to the Kaboom attendance and behavioral policy.
- 4) Scholarship recipients are also required to maintain at least a "C" average at school. Report cards will be reviewed by Shafonia at the end of each six weeks.
